Mayor Stewart called the meeting to order at 6:30 p.m.

Before the minutes were presented for adoption, the following new business was addressed as follows:

- 1. <u>Down Home Magazine:</u> It was noted that the Down Home Magazine did an article on Harbour Breton in their last issue. Recommends that an ad be put on the community channel advising residents of this. Also, recommending that Mr. Ron Young, founding editor of the Down Home be invited to attend the Opening Ceremonies;
- 2. <u>Business Tax /Boarding Homes:</u> Inquiry from a resident with regards to the fact that others are taking in boarders and are not being charged 'business tax'. Agreed to send a business tax bill out to that individual;
- 3. <u>Minutes on website:</u> After discussion on 're-posting the minutes on website', a motion was made as follows:

Resolved that the minutes of the regular meetings are to be reinstated back on the town's website, effective minutes of April 2, 2008.

- 4. <u>Roofing Company:</u> Recommends that the town super meet with the roofing company presently doing work on the school and advise them that the old shingles must be buried and not burnt. Also, remind them that they are responsible for a dumping fee & a permit;
- 5. <u>Recreational scallop fishing:</u> Recommends that a letter be sent to DFO regarding the recent restriction being placed on recreational scallop fishers, which does not apply to the commercial fishers, in that they are not permitted to scallop fish in certain areas. Check file to find out if a letter was sent previously to DFO on a similar matter;
- 6. <u>2008 Celebrations</u>: Discussion as to why are all the dances are scheduled for the arena, whereas the town just spent additional \$\$ on the 'new festival site'? This is mainly due to the 'sound system' and for 'security' reasons. Recommending that if any individual volunteers for 2008 celebrations, they will not be asked to pay admission;
