Mayor also indicated that once legislation is reviewed regarding the 'fish being trucked out', letters from the Joint Mayors will be forwarded to the Minister;

Recommends that a letter be forwarded to the Canadian Coast Guard requesting that the area in question where they cut the trees be cleaned up;
2. Resident on 16 Spencer's Brook Road: Requesting a donation towards cost for the upcoming "Dove Self Esteem Fund) & asking if the Town would be interested in having a some type of meet/greet for Miss NL. Agreed to give them the option of going to the Coffee Shop & Town to cover the cost;

3. Ms Teen NL: Informing that she is available to visit the community, but must provide meals & accommodations. Copy to CYN & Recreation Commission;
